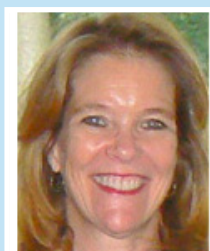

Committee Reports

Fund-raising Committee

Fund raising expanded through our presence at four Regional Conferences this year. It was our first year to have a dedicated representative at the Conferences in Minnesota, California, Ohio and New York. Each of these regions offered us a Table as well as an opportunity to hold raffles and offer information about the work of HTWF. We brought in, through the generosity of the participants, about \$3,000, which represented new donation income to the Foundation.

The Board set their monetary intent for the Annual HTP Conference. Again, the giving hearts of the HTP membership overwhelmed the Foundation with not only donations for the Live Auction, Silent Auction and Raffle, which was new for us this year, but also with the bids for these donated items. We raised \$13,600. This is the highest amount ever in our history as part of the Annual Conference for HTP.

The plans for 2011 are well underway. We expect that we will be increasing our presence with two to three more Regional Meetings. The entire Board is already working on gathering large donation items and sharing them via our website prior to the Annual Conference.

Grant Committee

The purpose of our Fund-raising is to respond to Grant applicants request for projects involving research, outreach, and service projects as well as bringing Non-U.S. Certified Practitioners to the United States to take the Level 6 Instructors' class. This year the Committee created a more formal structure for Grant review and handling. Additionally, positions for non-board members were opened to expand the functionality of this Committee.

We are pleased to share that two Grants were given this year from the Janet Mentgen Fund. The first was for Aparna Bhutta from Nepal. A story of her journey is shared on our website. The second was for Ainslie Allison of Western Australia. You will hear more of her story in 2011. These two Grants totaled \$8,000.

We believe Grant application submissions will continue to increase in 2011. We are working on new Grant Fund activities and hope to release them in early 2011. The Committee looks forward to continuing Janet Mentgens' dream of spreading the Light through Healing Touch.
